APPLICATION TERMS

The parts and labor warranty coverage periods in the above table are based on a typical container chassis rail application. Hendrickson, at its sole discretion, may adjust warranty coverage on a case-by-case basis for chassis axles used in other applications during the respective warranty period. This warranty coverage applies only to those HCA® intermodal chassis axles that have been (i) properly assembled and installed by an original equipment manufacturer (OEM), (ii) properly maintained (as described in all applicable Hendrickson publications), (iii) operated only within the United States, Canada, or Mexico, and (iv) used in their recommended applications and within the rated capacities. All non-recommended intermodal chassis axle applications must receive written approval from Hendrickson in order to be covered under the warranty. This warranty is subject to the conditions, exclusions and limitations listed in Hendrickson publication L583 Comprehensive Warranty Statement available at www.Hendrickson-intl.com/TrailerLit. See publication L583 for additional information.

The Hendrickson warranty coverage begins when the chassis axle is put into service and ends when the time period specified in the above-referenced coverage table is reached.

No expressed warranty is given by Hendrickson with respect to its intermodal chassis axles and related components except as specifically set forth herein and in publication <u>L583</u>. Any warranty implied by law, including any warranty of merchantability or fitness for a particular purpose, is limited to the expressed warranty term provided in the above-referenced warranty-coverage table and/or publication L583.

MILEAGE TERMS

The parts and labor warranty coverage periods in the above table are based on a typical annual average usage of less than 15,000 miles. However, some applications may exceed 15,000 miles per year. Hendrickson, at its sole discretion, may adjust warranty coverage on a case-by-case basis for applications exceeding 15,000 miles per year during the respective warranty period.
